Routepass terms and conditions

- 1 Routepass tickets are valid only on specified non-stop bmi operated shorthaul UK Domestic and Western European services (excluding midhaul and longhaul) and cannot be reissued for travel on another airline. Routepass is currently only available for sale in the European Union.
- 2 Routepass is available on any bmi operated route on a C or Y class fare. It is not available on codeshare routes operated by other airlines or bmibaby routes.
- 3 All travel must be completed within the period of the Routepass ticket's validity (four calendar months from the date of first outbound flight).
- 4 The first outbound flight must be booked at the time of purchase. Routepass tickets are available by postal delivery from bmi. Routepass is also available from the bmi ticket desk at the airport of departure.
- 5 Routepass tickets are interchangeable for certain routes; those purchased Heathrow – Edinburgh can also be used to Glasgow and vice versa without exchange of tickets. The same rule applies for Manchester – Edinburgh/Glasgow and Leeds Bradford – Edinburgh/Glasgow.
- 6 Routepass tickets for the individual are only for use by a single named passenger whose name will appear on each ticket. Routepass tickets for a company are valid for company employees who must provide proof of identity prior to travel.
- 7 During the four month validity period, Routepass tickets may be used as part payment towards any bmi business fare or full economy fare if the passenger wishes to travel on a bmi operated route other than that specified on the ticket.
- 8 For part payment, passengers may exchange one Routepass ticket for a single journey to a maximum of two for a return journey.
- 9 The value of the Routepass ticket for exchange purposes is 1/10 of the complete ticket book original purchase price including taxes for the individual, and 1/20 of the total purchase price for the company option.
- 10 The difference in value between the Routepass ticket(s) and the new itinerary must be paid in full before tickets can be issued.
- 11 If the sum of the Routepass ticket(s) used for part payment is greater than the replacement fare, the difference in value is non-refundable.
- 12 Routepass tickets are non-refundable. No retrospective refunds for unused tickets are permitted.
- 13 Tickets become invalid if altered or defaced. The only exception to this rule is Routepass tickets for a company where the passengers name will be handwritten on the tickets.
- 14 Tickets cannot be resold or exchanged for cash.
- 15 A Routepass for an individual entitles that customer to immediate Diamond Club Silver membership, and for the company option five employees are eligible for instant Blue Plus membership with a credit of 8000 membership status miles to their Diamond Club account to reach Silver membership faster. Passengers will be invited to enrol by the bmi call centre or may complete the special Diamond Club application form issued with their first Routepass ticket book. Existing Diamond Club Blue or Blue Plus members should indicate their membership number to facilitate an upgrade to silver for the individual option, or credit of 8000 membership status miles for the company option.
- 16 Silver Diamond Club membership is valid for a period of 12 months, during which time 16000 membership points need to be earned to retain this level.
- 17 bmi tickets are subject to the provisions of the Carriage by Air Act 1961 and orders made thereunder, and all passengers, their luggage and belongings are carried on the terms contained in bmi's General Conditions of Carriage. Regulations, timetables and notices may be inspected at bmi's offices.

RoutePASS terms and conditions

18 These terms and conditions are correct at the time of publishing. bmi reserves the right to make changes without prior notice.

A binding contract is not formed until bmi accepts a customer's offer to buy a ticket. An offer will be deemed to have been accepted by bmi once the customer is in receipt of a booking confirmation. Prices are subject to change at any time before acceptance by bmi. All flights and products are all offered subject to availability.

Notwithstanding the foregoing, in the event of a genuine website error or inaccuracy, bmi reserves the right to withdraw an offer immediately. bmi reserves the right to cancel all confirmed bookings that are subject to genuine website error or inaccuracy. In the event of such cancellation bmi's only liability shall be to refund the ticket price paid by the customer.
